ORDER

This cause having come before the State of Alabama Board of Licensure for Professional Engineers and Land Surveyors on a complaint against John H. Crigler, hereafter referred to as Respondent, and the Board having considered the evidence presented, the Board has made the following determinations:

COUNT ONE

Respondent placed his professional seal and signature to design plans for Small's Mortuary that contained errors, omissions and code violations.

Respondent is guilty. Respondent's license to practice engineering in the State of Alabama shall be suspended effective from date of this Order for a period of two years, he shall serve three years probation commencing from date license suspension ends and shall pay the State of Alabama Board of Licensure For Professional Engineers and Land Surveyors a fine of \$2,500.00.

COUNT TWO

Respondent prepared site design plans for Mr. Bob O'Berry that contained code violations.

Respondent is guilty. Respondent's license to practice engineering in the State of Alabama shall be suspended effective from date of this Order for a period of two years and shall

run concurrent with suspension in Count One, he shall serve three years probation concurrent with Count One and shall pay the State of Alabama Board of Licensure For Professional Engineers and Land Surveyors a fine of \$2,500.00.

COUNT THREE

Respondent prepared site design plans for Ms. Juanita Karr that contained code violations.

Respondent is guilty. Respondent's license to practice engineering in the State of Alabama shall be suspended effective from date of this Order for a period of two years and shall run concurrent with suspension in Count One and Count Two, he shall serve three years probation concurrent with Count One and Count Two and he shall pay the State of Alabama Board of Licensure For Professional Engineers and Land Surveyors a fine of \$2,500.00.

COUNT FOUR

Respondent, John H. Crigler, failed to provide subpoenaed documents to the Board concerning the investigation of a complaint filed by Mr. Bob O'Berry.

Respondent is guilty. Respondent's license to practice engineering in the State of Alabama shall be suspended effective from date of this Order for a period of two years and shall run concurrent with Count One, Count Two and Count Three, he shall serve three years probation and it shall run concurrent with Count One, Count Two and Count Three and shall pay the State of Alabama Board of Licensure For Professional Engineers and Land Surveyors a fine of \$2,500.00.

COUNT FIVE

Respondent, John H. Crigler, failed to provide subpoenaed documents to the Board concerning the investigation of a complaint filed by Ms. Juanita Karr.

Respondent is guilty. Respondent's license to practice engineering in the State of Alabama shall be suspended effective from date of this Order for a period of two years and it

shall run concurrent with Count One, Count Two, Count Three and Count Four, he shall serve three years probation and it shall run concurrent with Count One, Count Two, Count Three and Count Four and shall pay the State of Alabama Board of Licensure For Professional Engineers and Land Surveyors a fine of \$2,500.00.

COUNT SIX

Respondent, John H. Crigler, placed his professional seal and signature to design plans that contained errors, omissions and code violations.


Respondent is guilty. Respondent's license to practice engineering in the State of Alabama shall be suspended effective from date of this Order for a period of two years and it shall run concurrent with Count One, Count Two, Count Three, Count Four and Count Five, he shall serve three years probation and it shall run concurrent with Count One, Count Two, Count Three, Count Four and Count Five.


THEREFORE, it is HEREBY ORDERED AND ADJUDGED that:





Failure to submit payment of specified fine shall cause Respondent's license to practice engineering in the State of Alabama to be revoked effective six months from date of this Order.


STAY of ORDER




It is hereby ORDERED and ADJUDGED that the suspension of the Respondent's license to practice engineering in the State of Alabama rendered on July 25, 2003 is stayed pending judicial review. Respondent shall pay the Board the assessed fine of 12,5000.00 in accordance with the Order rendered July 25, 2003 and pursuant to Title 34 Chapter 11, Code of Alabama 1975 Section 34-11-11(j) in the event the fine is subsequently set aside on judicial review the Respondent, shall be entitled to a prompt refund of the amount of the fine, but shall not be entitled to interest thereon.


ORDER

The State of Alabama Board of Licensure for Professional Engineers and Land Surveyors, hereafter referred to as Board, after being sufficiently notified by Judge Tracey McCooley of the Montgomery County Circuit Court concerning the dismissal of the pending appeal of the Board's Order issued July 25, 2003 relative to Mr. John H. Crigler, hereafter referred to as Respondent, determines as follows:

It is hereby **ORDERED** and **ADJUDGED** the Board's Order issued July 25, 2003 is reinstated requiring Respondent's license to practice engineering in the state of Alabama to be suspended for two years effective from date of this Order, for Respondent to serve three years probation commencing from the date his license suspension ends and Respondent to pay the Board the fine of \$12,500.00.

Failure to submit payment of specified fine prior to September 3, 2004 shall cause Respondent's license to practice engineering in the State of Alabama to be revoked.


