

**MINUTES OF FIFTH MEETING
2018-2019 BOARD OF LICENSURE
FOR PROFESSIONAL ENGINEERS AND LAND SURVEYORS
Montgomery, Alabama
July 16, 2019**

The Alabama Board of Licensure for Professional Engineers and Land Surveyors was established by legislative action in 1935. Its charter is to protect the public by helping to safeguard life, health, and property, and to promote the public welfare by providing for the licensing and regulation of persons in the practices of engineering and land surveying. This purpose is achieved through the establishment of minimum qualifications for entry into the professions of engineering and land surveying, through the adoption of rules defining and delineating unlawful or unethical conduct, and through swift and effective discipline for those individuals or entities who violate the applicable laws or rules.

Board meeting notices are posted on the Open Meetings area of the website of the Secretary of State, and the Board's website under Dates and Deadlines.

Chair Johnson called the fifth meeting of the 2018-2019 Board to order at 8:00 A.M., Tuesday July 16, 2019, at the Board Office in Montgomery, Alabama. He noted that there was a quorum of Members present and the meeting began with the pledge of allegiance and a prayer.

The proposed meeting agenda was reviewed.

19-085. IT WAS MOVED by Ms. Adams-Morales and seconded by Mr. Barter to adopt the agenda as proposed. MOTION CARRIED 7-0.

Minutes of the fourth meeting of the 2018-2019 Board held on May 6-8, 2019, were reviewed.

19-086. IT WAS MOVED by Mr. Whorton and seconded by Ms. Adams-Morales that the minutes of the fourth meeting of the 2018-2019 Board held May 6-8, 2019, be approved. MOTION CARRIED 7-0.

The Board recognized Ms. Denise Hooper of Board Staff for her fifty-one years of service to the State of Alabama. Ms. Hooper was presented with a Senate Congratulatory Certificate in appreciation of her service.

Mr. Christopher Knotts, National Council of Examiners for Engineering and Surveying (NCEES) Southern Zone Vice President, made a presentation to the Board regarding the services provided by NCEES.

Action items from previous meetings were reviewed. The Board was updated on the progress of creating a Law and Administrative Code two-hour course for licensees.

HEARINGS

A hearing regarding the denied professional engineer application of Alexander Barghout began at 9:00 A.M. Mr. Barghout had previously submitted an application that the Board denied based on his failing to report a criminal violation on his application. Mr. Barghout was present at the hearing and provided information.

19-087. IT WAS MOVED by Mr. Barter and seconded by Ms. Hyde to approve for licensure the application of Alexander Barghout. MOTION CARRIED 7-0.

A hearing regarding the denied professional engineer application of Michael Patrick Kelly Jr., began at 9:20 A.M. Mr. Kelley had previously submitted an application that the Board denied based on his failing to report a criminal violation on his application. Mr. Kelley was present at the hearing and provided information.

19-088. IT WAS MOVED by Mr. Barter and seconded by Ms. Hyde to approve for licensure the application of Michael Patrick Kelley Jr. MOTION CARRIED 7-0.

A hearing regarding the denied professional engineer examination application of Kevin Pugh began at 9:45 A.M. Mr. Pugh had previously submitted an application that the Board denied based on insufficient engineering experience and inadequate supervision. Mr. Pugh was present at the hearing and provided information.

19-089. IT WAS MOVED by Mr. Barter and seconded by Ms. Hyde to deny the application for examination of Kevin Pugh. MOTION CARRIED 7-0.

A hearing regarding the denied professional land surveyor application of Graeme Kaiser began at 10:10 A.M. Mr. Kaiser had previously submitted an application that the Board denied based on his Bachelor of Science Degree in Business Administration not being related to land surveying. Mr. Kaiser was present at the hearing and provided information.

19-090. IT WAS MOVED by Mr. Barter and seconded by Ms. Hyde to deny the application for examination of Graeme Kaiser. MOTION CARRIED 7-0.

OPEN FORUM

Mr. Rusty Blackwell, President of the Alabama Society of Professional Land Surveyors (ASPLS) spoke with the Board regarding government employees located in Tax offices advising members of the

public that a survey performed by a licensed professional land surveyor was wrong because it did not match their documents. Board Member Joseph F. Breighner Jr., agreed to draft a letter to be sent to government agencies regarding this issue.

LAW ENFORCEMENT – Ms. M. Elisabeth Hyde, Advisor

The Board reviewed the status of the files pending with the Investigators, and the Investigative Committee. The Board was briefed on the 2018-2019 statistics.

The Board reviewed pending cases presented by the investigative committees to accept, modify, or reject the recommended actions. The cases were discussed in a sanitized format to avoid compromising due process for the Respondent in the event the Board determined another course of action.

At 11:10 AM the Board determined to go into Executive Session to deliberate the recommendations of Administrative Law Judge Jerry Wood regarding disciplinary hearings held on May 6, 2019, and May 8, 2019. Attorney Ben Albritton confirmed that it was permissible for the Board to enter Executive Session for this matter.

19-091. IT WAS MOVED by Ms. Hyde and seconded by Ms. Adams-Morales that the Board go into executive session for fifteen minutes to deliberate. MOTION CARRIED 7-0 with Mr. Johnson, Ms. Hyde, Mr. Whorton, Mr. Grace, Mr. Barter, Ms. Adams-Morales and Mr. Breighner voting for the executive session.

The Board exited the Executive Session at 11:25 AM.

19-092. IT WAS MOVED by Ms. Adams-Morales and seconded by Mr. Whorton that the Board accept the recommendations of ALJ Jerry Wood and issue a final order thereby closing Case 2017-15-C. MOTION CARRIED 3-2-1-1 with Ms. Adams-Morales, Mr. Whorton and Mr. Breighner voting for the motion, Mr. Barter and Ms. Hyde voting no on the motion, Mr. Grace abstaining from the vote, and Mr. Johnson recused from the vote.

19-093. IT WAS MOVED by Mr. Barter and seconded by Ms. Hyde that the Board modify the proposed disciplinary recommendations of ALJ Jerry Wood and issue a final order thereby closing Case 2018-13-B. MOTION CARRIED 6-0 with Mr. Grace recused.

19-094. IT WAS MOVED by Mr. Grace and seconded by Mr. Barter that the Board accept the recommendations of the investigative committee and close Case 2019-13 with no action. MOTION CARRIED 6-0 with Mr. Whorton recused.

19-095. IT WAS MOVED by Mr. Whorton and seconded by Ms. Adams-Morales that the Board accept the recommendations of the investigative committee and close Case 2019-18 with no action. MOTION CARRIED 6-0 with Ms. Hyde recused.

19-096. IT WAS MOVED by Ms. Adams-Morales and seconded by Mr. Grace that the Board accept the consent order and issue a final order thereby closing Case 2019-19. MOTION CARRIED 6-0 with Mr. Barter recused.

The Board recessed for lunch at 12:10 P.M.

The Board reconvened at 12:50 P.M.

APPLICATIONS – Mr. Nathan G. Johnson, Advisor

The Board previously authorized the Executive Director to approve applications for licensure, intern certification, and examinations if the application is in order and all requirements have been met. Applications of those applying for Professional Engineer licensure by comity since May 6-8, 2019, as provided by Section 34-11-4(1)(b) of the Licensure Law, were considered.

Applications of those applying for Professional Engineer licensure by examination since May 6-8, 2019, as provided by Section 34-11-4(1)a and b, of the Licensure Law having previously passed the FE Examination in Alabama or in another jurisdiction, were considered.

Applications of those applying for Engineer Intern certification since May 6-8, 2019, as provided by Section 34-11-4(2) of the Licensure Law, were considered.

Applications of those applying for Professional Land Surveyor licensure since May 6-8, 2019, as provided by Section 34-11-4(3)a and b of the Licensure Law, were considered.

Applications of those applying for Professional Land Surveyor licensure since the May 6-8, 2019, having previously passed the Fundamentals of Land Surveying Examination and the Principles and Practice of Land Surveying Examination in Alabama or in another jurisdiction were considered and were approved to take the Alabama Land Surveying Standards, History, and Law Examination.

19-097. IT WAS MOVED by Mr. Whorton and seconded by Mr. Grace that the Board ratify the approval of licenses issued since the May 6-8, 2019, meeting and that the list of those be included in the minutes on **Attachment #1**. MOTION CARRIED 7-0.

19-098. IT WAS MOVED by Mr. Whorton and seconded by Mr. Breighner that the Board ratify the approval of Intern Certifications issued since the May 6-8, 2019, Board Meeting and that the list of those be included in the minutes on **Attachment #2**. MOTION CARRIED 7-0.

19-099. IT WAS MOVED by Mr. Whorton and seconded by Mr. Grace that the Board ratify the approval of exam applicants approved since the May 6-8, 2019, Board Meeting and approve for examination the applicants listed on **Attachment #3**. MOTION CARRIED 7-0.

19-100. IT WAS MOVED by Mr. Whorton and seconded by Mr. Grace to deny for licensure the application of Edward E. Flagg, Richard M. Cole, Benjamin K. Bacon, John B. Grace Jr., David A. Lallone, and John L. Jett. MOTION CARRIED 7-0.

19-101. IT WAS MOVED by Mr. Whorton and seconded by Mr. Grace to defer for licensure the application of Lee William Howard and Bashar Al Akayshee, MOTION CARRIED 7-0.

19-102. IT WAS MOVED by Mr. Whorton and seconded by Ms. Hyde to close the listed inactive applications and include them on **Attachment #4**. MOTION CARRIED 7-0.

19-103. IT WAS MOVED by Mr. Barter and seconded by Mr. Breighner to deny for examination the applications of Cameron Scot Lowe, Kevin Pugh and Graeme Kaiser. MOTION CARRIED 7-0.

The Board reviewed a Request from Mr. Benjamin Kimbrough that it Evaluate his transcript to determine if it qualified as being Related to Surveying. Mr. Kimbrough received a Bachelor of Science Degree in Geography from the University of South Alabama. After its review the Board determined Mr. Kimbrough would need an additional 2 courses for the degree to qualify as Related to Surveying.

19-104. IT WAS MOVED by Mr. Johnson and seconded by Mr. Breighner to inform Mr. Kimbrough his degree would be classified as a related to surveying degree and he would need an additional two surveying classes to be eligible for licensure. MOTION CARRIED 7-0.

The Board reviewed a Request from Mr. Chad Orrell that it Evaluate his Transcript to determine if it qualified as being a Related Science to Surveying. Mr. Orrell received a Bachelor of Science Degree in Geography from the University of South Alabama. After its review the Board determined the degree met the requirements as a Related Science degree and Mr. Orrell would need 6 years of experience to qualify for licensure.

19-105. IT WAS MOVED by Mr. Johnson and seconded by Ms. Hyde to approve Mr. Orrell's Bachelor of Science Degree in Geography as a Related Science to Surveying and to advise him that 6 years of experience would be necessary to qualify for licensure. MOTION CARRIED 7-0

The Board reviewed a Request from Mr. Matthew Carter to evaluate courses he completed at the University of Tennessee to determine if they would qualify as a portion of the 15 surveying credit hours necessary for Land Surveyor Intern Certification. After its review the Board determined the courses would meet 7 of the semester hour requirements and Mr. Carter would need an additional 8 semester hours to qualify for Land Surveyor Intern Certification.

The Board reviewed a request from Mr. Jeffrey Devine that it allow him to qualify for certification as a Land Surveyor Intern, based on his passing the Fundamentals of Surveying (FS) exam. Mr. Devine passed the FS exam under a previous version of the Code of Alabama which did not require a degree. After its review the Board determined that Mr. Devine did not meet the requirements for certification as a Land Surveyor Intern.

The Board reviewed correspondence from Mr. Troy Paul Holcomb that requested the Board review his application for certification as a Land Surveyor Intern. Mr. Holcomb provided a college transcript that indicated he obtained a Bachelor of Science Degree in Civil Engineering from the University of Tennessee on May 9, 2015, and requested the Board evaluate the degree as a Related Science Degree. After its review the Board determined the degree would be classified as a Related Science degree and that Mr. Holcomb be advised of the requirements for licensure as a professional land surveyor with a related science degree.

The Board reviewed a request from Ms. Kari Peterson Servold that it evaluate her related Science Degree for her application for certification as an Engineer Intern. Ms. Peterson provided a college transcript that shows she obtained a Bachelor of Science Degree in Geography in May 2012, from the University of Alabama and a Master of Science Degree in Civil Engineering from the University of

South Alabama in December 2015. After its review the Board determined that her Bachelor of Science Degree in Geography was not a related science to engineering.

The Board reviewed an Engineer Intern application submitted by Mr. Nicholas Watson that indicated he received a Bachelor of Science Degree in Mechanical Engineering from the University of South Alabama in May 2019. The application also indicated there were pending criminal charges against Mr. Watson. The Board determined it would not consider the application until such time as the outcome of the legal action had been decided.

19-106. IT WAS MOVED by Mr. Whorton and seconded by Mr. Grace to deny for intern certification the application of Nicholas Watson. MOTION CARRIED 7-0.

CERTIFICATES OF AUTHORIZATION – Ms. Adams-Morales, Advisor

The Board authorizes the Executive Director to issue certificates of authorization to applying firms if the application is in order and all requirements have been met. A list of the certificate of authorizations issued since the May 6-8, 2019, Board Meeting were reviewed.

19-107. IT WAS MOVED by Ms. Adams-Morales and seconded by Mr. Breighner that the Board ratify the approval of the Engineering and Land Surveying Certificates of Authorization issued since the May 6-8, 2019, Board Meeting and that the list of those issued be included in the minutes on **Attachment #5**. MOTION CARRIED 7-0.

COMMUNICATIONS AND PUBLICATIONS - Mr. Marc S. Barter, Advisor

The Board was briefed on current Outreach activities.

FINANCE – Mr. Richard G. Grace, Advisor

The monthly financial reports for May and June were briefed.

ENGINEERING EDUCATION & EXAMINATIONS - M. Elisabeth Hyde, Advisor

The Board reviewed information provided by NCEES related to upcoming exam changes, exam schedules, new exam specifications, and a summary of examination results from the April 5, 2019, exam offering.

EXECUTIVE DIRECTOR'S REPORT

The Board was briefed on the award of the bid for conversion of microfiche to pdf, and items that may generate discussion at the NCEES annual meeting in August.

The Board reviewed resumes of professional engineers wishing to be considered for appointment to the Alabama Onsite Wastewater Board.

19-108. IT WAS MOVED by Mr. Barter and seconded by Mr. Whorton that the names of Sharon Kimbrough, Wheeler Crook and Wynn C. Echols be submitted to the Speaker of the House for his consideration. MOTION CARRIED 7-0.

The Board discussed the motion it planned to present at the NCEES annual meeting in August. After discussion the Board determined that Mr. Barter would draft the motion to be provided to the Executive Director for distribution to the other Board Members for review.

CORRESPONDENCE

The Board reviewed a request from Mr. William C. Dunn of SunCam Inc, that it provide his firm a list of email addresses of Alabama licensees. The Board also reviewed the Code of Alabama and determined that email addresses of licensees are confidential and cannot be released.

19-109. IT WAS MOVED by Mr. Whorton and seconded by Mr. Breighner that the Board deny Mr. Dunn's request. MOTION CARRIED 7-0.

The Board reviewed a request from Mr. Donald H. Olds that he be granted the right to use the title "Professional Engineer, Retired."

19-110. IT WAS MOVED by Mr. Barter and seconded by Ms. Adams-Morales that the Board grant approval for Donald H. Olds to use the title "Professional Engineer, Retired". MOTION CARRIED 7-0.

The Board reviewed correspondence from Ms. Beth Mundy, Assistant to the Chief Accreditation Officer of ABET, regarding an upcoming ABET visit in November 2019, and inquiring if the Board wished to send an observer on the visit.

19-111. IT WAS MOVED by Mr. Barter and seconded by Mr. Grace that Mr. Nathan Johnson's name be submitted to attend the ABET visit. MOTION CARRIED 7-0.

The Board reviewed correspondence submitted by Ms. Cynthia W. Peeler for Engineering Specialties Co, Inc, that requested the Board allow the organization's name to contain the word "Engineering" without having to meet the certificate of authorization requirements. The Board determined the word "Engineering" in the firm name did not tend to convey that the organization was offering engineering services.



NEW BUSINESS






