

**MINUTES OF FIFTH MEETING
2016-2017 BOARD OF LICENSURE
FOR PROFESSIONAL ENGINEERS AND LAND SURVEYORS
Montgomery, Alabama
March 23, 2017**

Chair Christy called the fifth meeting of the 2016-2017 Board to order at 8:00 A.M., Thursday, March 23, 2017 at the Board Office, Montgomery, Alabama. The following were in attendance:

It was determined that a quorum was present. The meeting was opened with the Pledge of Allegiance and a prayer.

The proposed meeting agenda was reviewed.

17-064. IT WAS MOVED by Mr. Johnson and seconded by Ms. Hyde to adopt the agenda as proposed. MOTION CARRIED 6-0.

Minutes of the fourth meeting of the 2016-2017 Board were received for approval.

17-065. IT WAS MOVED by Ms. Hyde and seconded by Mr. Barter that the minutes of the fourth meeting of the 2016-2017 Board held March 23, 2017 be approved as corrected. MOTION CARRIED 6-0.

Action items from previous meetings were reviewed.

APPLICATIONS – Mr. Nathan Johnson, Advisor

Mr. Matthew Brown met with the Board and presented information regarding his professional engineer license application. The primary issue was that his undergraduate degree was from Pensacola Christian, and at the time of his graduation the college was not regionally accredited nor was his engineering degree ABET accredited. The degree was later ABET accredited.

Board determined that Mr. Brown's degree would be considered as substantially equivalent to a graduate of an unaccredited engineering degree, and approved him as a graduate of an unaccredited engineering curriculum. The Board further determined that he be required to obtain 72 months of acceptable engineering experience in order to be eligible for PE licensure.

17-066. IT WAS MOVED by Mr. Johnson and seconded by Mr. Whorton to approve Mr. Brown as being substantially equivalent to a graduate of an unaccredited engineering degree, and as such requires 72 months of acceptable engineering experience in order for him to be eligible for PE licensure. MOTION CARRIED 6-0.

The Board met with Mr. Kevin Jamal Pugh, a previously denied applicant, and his PE supervisor Torris Babbs regarding the status of his application. Additional information was presented on his work experience and the Board determined it would grant Mr. Pugh 30 months of qualifying engineering experience for the period between June 2010 – March 2017.

17-067. IT WAS MOVED by Ms. Hyde and seconded by Mr. Johnson that the Board deny Mr. Pugh's application to sit for the PE examination. MOTION CARRIED 6-0.

HEARINGS

William Varnon, submitted a Reissuance of his Revoked Professional Land Surveyor License application and presented information to the Board regarding his application.

The Board went into executive session to deliberate on the testimony presented by witnesses in consideration of Mr. Varnon's application. Mr. Albritton, board attorney verified that the reason for the executive session met the requirements of the open meetings law.

17-068. IT WAS MOVED by Mr. Barter and seconded by Ms. Hyde to go into executive session. Voting in the affirmative were Mr. Barter, Mr. Christy, Mr. Grace, Ms. Hyde, Mr. Johnson, and Mr. Whorton.

At 10:45 A.M. Mr. Christy announced that the board would go into executive session for approximately 15 minutes. The Board came back into open session at 10:55 A.M. During the deliberation Mr. Johnson was recused.

17-069. IT WAS MOVED by Mr. Grace and seconded by Ms. Hyde that the Board deny Mr. Varnon's application for reissuance of his professional land surveyor license. MOTION CARRIED 5-0 with Mr. Johnson recused.

The Board determined to take certain Agenda Items out of Order to accommodate members of the public in attendance.

LEGISLATIVE – Mr. Randall Whorton, Advisor

The efforts for introducing legislation during the 2017 Legislative Session were discussed.

It was noted that a motion had been made at the January board meeting that a discussion was to be held at the February board meeting. Since there was no February board meeting the discussion was added to this agenda. The status of the proposed rule changes was discussed. It was noted that the legislation

giving immunity to the board was still a viable option. It was the consensus of the board that no action would be taken on the proposed rules which then would cause the rule proposals to die 90 days after the final date for comments.

The Board discussed a Request for a Declaratory Ruling received from Ms. Heather Whorton Page regarding Rule 330-X—14-.05(f) Qualification Based Selection.

17-070. IT WAS MOVED by Mr. Barter and seconded by Ms. Hyde the Declaratory Ruling state that under existing Rule 330-X-14-.05(f) seeking a price from a single professional is not a violation of Qualification Based Selection when the professional has been predetermined to be qualified to provide the services. MOTION CARRIED 6-0.

APPLICATIONS – Mr. Nathan Johnson, Advisor

The Board met with Mr. Christopher Wayne Hill, a previously denied applicant, about the status of his application. Additional information was presented on work experience and education.

17-071. IT WAS MOVED by Mr. Johnson and seconded by Mr. Barter that the Board grant Mr. Hill 24 months of qualifying experience prior to graduation since he attended school longer than six years and allow him to sit for the PS and ALLS examination. MOTION CARRIED 6-0.

The Board met with Mr. Billy Alex McConathy, a previously denied applicant, and his PE supervisor Howard Michael Richards about the status of his application. Additional information was presented on his work experience and the Board determined it would grant Mr. McConathy 36 months of qualifying engineering experience for the period between January 2011 – March 2017.

17-072. IT WAS MOVED by Ms. Hyde and seconded by Mr. Johnson that the Board deny Mr. McConathy's application to sit for the PE examination. MOTION CARRIED 6-0.

The Board considered a Transcript Evaluation Report from Mr. Clay Richardson, a prospective land surveying applicant, concerning a Building Science Degree obtained from Auburn University. The Board determined to accept the applicants Building Science Degree as a Surveying Related Science.

17-073. IT WAS MOVED by Ms. Hyde and seconded by Mr. Johnson that the Board accept Mr. Richardson's Building Science Degree in a Related Science category. MOTION CARRIED 6-0.

The Board further determined that it would continue to accept the Auburn University BS in Building Science as a related science degree as it applies to land surveying licensure and that they no longer needed to individually approve those transcript evaluations.

The Board discussed the use of a mentorship supervision process for the verification of qualifying experience.

The Board previously authorized the Executive Director to approve applications for licensure, intern certification, and examinations if the application is in order and all requirements have been met. All applications for licensure, intern certification and examinations issued since the November 2016 Board meeting were reviewed.

Applications of those applying for Professional Engineer licensure by comity, as provided by Section 34-11-4(1)(b) of the Licensure Law, were considered.

Applications of those applying for Professional Engineer licensure by examination, as provided by Section 34-11-4(1)a. and b. of the Licensure Law having previously passed the FE Examination in Alabama or in another jurisdiction, were considered.

Applications of those applying for Engineer Intern certification, as provided by Section 34-11-4(2) of the Licensure Law, were considered.

Applications of those applying for Land Surveyor licensure by examination, as provided by Section 34-11-4(3)a., b., and c. of the Licensure Law, were considered. Applications of those applying for Professional Land Surveyor licensure by examination having previously passed the Fundamentals of Land Surveying Examination and the Principles and Practice of Land Surveying Examination in Alabama or in another jurisdiction were considered and were approved for the Alabama Land Surveying Standards, History, and Law Examination.

17-074. IT WAS MOVED by Mr. Barter and seconded by Mr. Grace that the Board ratify the approval of licenses issued since the January 31 – February 1, 2017 Board Meeting and that the list of those issued be included in the minutes on **Attachment #1**. MOTION CARRIED 6-0.

17-075. IT WAS MOVED by Mr. Barter and seconded by Mr. Grace that the Board ratify the approval of Intern Certifications issued since the January 31 – February 1, 2017 Board Meeting and that the list of those be included in the minutes on **Attachment #2**. MOTION CARRIED 6-0.

17-076. IT WAS MOVED by Mr. Barter and seconded by Mr. Grace that the Board ratify the approval for examination those applicants approved since the January 31 – February 1, 2017 meeting and listed as approved on **Attachment #3**. MOTION CARRIED 6-0.

17-077. IT WAS MOVED by Mr. Grace and seconded by Mr. Johnson that the Board accept for licensure by comity those applicants listed on **Attachment #1**. MOTION CARRIED 6-0.

17-078. IT WAS MOVED by Ms. Hyde and seconded by Mr. Grace that the Board deny for licensure John Boyd Ellis and Marc August Hemrick. MOTION CARRIED 6-0.

17-079. IT WAS MOVED by Ms. Hyde and seconded by Mr. Grace that the Board approve for examination those applicants listed on **Attachment #3**. MOTION CARRIED 6-0.

LAW ENFORCEMENT – Ms. M. Elisabeth Hyde, Advisor

The Board reviewed the status of the files pending with the Board, the Investigator, and/or the Investigative Committee. The Board was briefed on the 2016-2017 statistics.

The Board reviewed pending cases that the investigative committees had completed to accept, modify, or reject the suggested courses of action. The cases were discussed in a sanitized format so that in the

event the Board suggests another course of action that the due process of the investigation has not been compromised. Respondent's information is not divulged until after the proposed consent order is accepted and a final order was approved.

17-080. IT WAS MOVED by Mr. Grace and seconded by Mr. Barter that the Board accept the Consent Order and issue a Final Order in reference to Case 2015-41-B. MOTION CARRIED 5-0 with Mr. Christy recused.

17-081. IT WAS MOVED by Ms. Hyde and seconded by Mr. Barter that the Board accept the Consent Order and issue a Final Order in reference to Case 2016-08-C. MOTION CARRIED 5-0 with Mr. Whorton recused.

17-082. IT WAS MOVED by Mr. Johnson and seconded by Mr. Grace to close Case 2017-07-C with no action. MOTION CARRIED 5-0 with Mr. Christy recused.

CERTIFICATES OF AUTHORIZATION – Mr. Randall D. Whorton, Advisor

The Board previously authorized the Executive Director to issue certificates of authorization to applying firms if the application is in order and all requirements have been met. A list of the certificate of authorizations issued since the January 2017 Board Meeting were reviewed.

17-083. IT WAS MOVED by Mr. Barter and seconded by Ms. Hyde that the Board ratify the approval of the Engineering and Land Surveying Certificates of Authorization issued since the January 31 – February 1, 2017 Board Meeting and that the list of those issued be included in the minutes on **Attachment #4**. MOTION CARRIED 6-0.

The Board discussed the Certificate of Authorization applications that had exceptions.

17-084. IT WAS MOVED by Mr. Grace and seconded by Mr. Johnson to approve the application for MB Services Inc. MOTION CARRIED 3-2-1. Mr. Grace, Mr. Johnson and Ms. Hyde voted to approve, Mr. Barter and Mr. Christy voted no, and Mr. Whorton recused.

FINANCE – Mr. Richard Grace, Advisor

The FY2017 financial report and the monthly financial reports for January and February 2017 were briefed.

EXECUTIVE DIRECTOR'S REPORT

The Board reviewed information regarding the NCEES Northeast/Southern Zone meeting scheduled for April 2017.

The Board discussed staff travel and determined to continue the current policy in which travel is at the discretion of the Board Chair and the Executive Director.

The Board was briefed on information provided at the NCEES Board President's Assembly in February 2017, which included the plan to move of all exams to a computer based format.

NEW BUSINESS

The Board considered a request from Mr. Bobby Tracy, President of Live Action General Engineering Inc., to be allowed to keep the term "engineering" in his firm's name without obtaining a certificate of authorization.

17-085. IT WAS MOVED by Ms. Hyde and seconded by Mr. Johnson to deny Mr. Tracy's request and to send the firm a certificate of authorization application. MOTION CARRIED 6-0.

PERSONNEL – Mr. Marc Barter, Advisor


The Board discussed personnel issues.
