Once the mail is opened and processed, an update will be posted as soon as possible.

Complete – means your application is going to be reviewed or ratified at the next scheduled Board Meeting unless otherwise stated. The next board meeting date is on the Application Status page or under Board Meeting Agenda & Dates on the website. If you meet the Model Law Engineer (MLE) requirements, your license will be mailed as soon as possible and ratified at the next meeting. Due to the amount of applications being processed, please do not call the office for the number. We are making every effort to issue them as quickly as possible.

Pending – means the information listed is what we need to complete your application. It is your responsibility to ensure this information is sent to the Board office. Your license cannot be issued until the information listed is received. It will take approximately 3-4 weeks for the license number to be issued once your application is complete.

Pending review of NCEES Record – means the record has been received but it has not been downloaded and reviewed to complete your application for Board review.

Inactive – means the information listed is what we need to complete your application and you have until the date listed to have the information sent. It is your responsibility to ensure this information is sent to the Board office. If the information needed is not received in the Board Office by the date listed, you will be required to file a new application and new fee.

Received hasn't been processed - means the application has been received in the Board office but has not had an initial review of the application to determine if the application is satisfactory and what if any information has been received on the application.
