

**MINUTES OF FIRST MEETING  
2019-2020 BOARD OF LICENSURE  
FOR PROFESSIONAL ENGINEERS AND LAND SURVEYORS  
Montgomery, Alabama  
November 6, 2019**

The Alabama Board of Licensure for Professional Engineers and Land Surveyors was established by legislative action in 1935. Its charter is to protect the public by helping to safeguard life, health, and property, and to promote the public welfare by providing for the licensing and regulation of persons in the practices of engineering and land surveying. This purpose is achieved through the establishment of minimum qualifications for entry into the professions of engineering and land surveying, through the adoption of rules defining and delineating unlawful or unethical conduct, and through swift and effective discipline for those individuals or entities who violate the applicable laws or rules.

Board meeting notices are posted on the Open Meetings area of the website of the Secretary of State, and the Board's website under Dates and Deadlines.

Chair Whorton called the first meeting of the 2019-2020 Board to order at 8:00 A.M., Wednesday November 6, 2019, at the Board Office in Montgomery, Alabama. He noted that there was a quorum of Members present and the meeting began with the pledge of allegiance and a prayer. The following Members and Staff were in attendance.

The proposed meeting agenda was reviewed.

Mr. Barter asked the Board to add an item for discussion under New Business. He advised he would like to discuss the possibility of adding discipline specific licensing for Structural and Construction engineering.

20-001. IT WAS MOVED by Mr. Johnson and seconded by Ms. Walton to adopt the agenda as proposed. MOTION CARRIED 9-0.

Minutes of the sixth meeting of the 2018-2019 Board held on September 9-10, 2019, were reviewed.

20-002. IT WAS MOVED by Mr. Vaughn and seconded by Ms. Adams-Morales that the minutes of the sixth meeting of the 2018-2019 Board held September 9-10, 2019, be approved. MOTION CARRIED 9-0.

During its review of Action items, the Board was updated on the proposed cost of creating the Law and Administrative Code two-hour course for licensees. The Board then determined that since it was time for the Public Hearing it would return to the discussion of the Action Items at the end of the day.

## **HEARINGS**

A scheduled public hearing regarding proposed rule changes was advertised for 8:00 am. The Board allowed all interested attendees to ask questions and provide their concerns with the proposed rule changes, and the public hearing ended at 8:30 am. The Board received no written comments related to the proposed rule changes.

20-003. IT WAS MOVED by Mr. Vaughn and seconded by Mr. Averrett to certify the rule changes and submit them to the Legislative Services Agency for review. MOTION CARRIED 9-0.

At 8:40 am Chair Whorton turned the meeting over to Administrative Law Judge Jerry Wood, to preside over a hearing on a disciplinary matter regarding Mr. David D. Woods, professional land surveyor. The hearing began at 8:40 am and ended at 10:00 am. ALJ Wood advised he would provide recommendations to the Board for its consideration.

A hearing regarding the denied engineer intern application of Ms. Kari Peterson Servold began at 10:05 am. Ms. Servold had previously submitted an application that the Board denied based on her BS degree not being a related science to engineering. Ms. Servold was present at the hearing and provided information.

20-004. IT WAS MOVED by Mr. Johnson and seconded by Mr. Vaughn to deny the engineer intern application of Kari Peterson Servold. MOTION CARRIED 8-0-1 with Mr. Averrett abstaining.

A hearing regarding the denied certificate of authorization for engineering application submitted by Barrett Woodyard & Associates Inc, began at 10:40 am. The firm had previously submitted an application the Board denied based on its failure to report a disciplinary action received in another state. Mr. Steve Brewer was present and represented the firm at the hearing.

20-005. IT WAS MOVED by Mr. Barter and seconded by Mr. Breighner to approve the engineering certificate of authorization application of Barrett Woodyard & Associates Inc. MOTION CARRIED 7-2 with Mr. Johnson and Ms. Walton opposed.

A hearing regarding the denied certificate of authorization for engineering and land surveying applications submitted by Quality Engineering and Surveying LLC, began at 10:55 am. The firm had previously submitted applications the Board denied based on its failure to report a disciplinary action received in another state. Mr. William Purser was present and represented the firm at the hearing.

20-006. IT WAS MOVED by Mr. Breighner and seconded by Ms. Baldwin that Quality Engineering and Surveying LLC, be required to submit a new application with the correct information and provide an explanation for providing wrong information on the first applications. Mr. Breighner withdrew the motion without a vote.

20-007. IT WAS MOVED by Mr. Barter and seconded by Mr. Breighner to approve the engineering and land surveying certificate of authorization applications of Quality Engineering and Surveying LLC upon receipt of applications that met the Board's certificate of authorization requirements. MOTION CARRIED 8-1 with Mr. Johnson opposed.

A hearing regarding the denied professional engineer application of Richard M. Cole began at 11:10 am. Mr. Cole had previously submitted an application that the Board denied based on his failing to report a criminal violation on his application. Mr. Cole was present at the hearing and provided information.

20-008. IT WAS MOVED by Mr. Vaughn and seconded by Mr. Averrett to deny the licensure application of Richard M. Cole. MOTION CARRIED 9-0.

The Board recessed for lunch at 12:05 pm.

The Board reconvened at 12:55 pm.

**APPLICATIONS** – Mr. Nathan G. Johnson, Advisor

The Board reviewed the professional engineer licensure application of Emad Badiee and made the following motion:

20-009. IT WAS MOVED by Mr. Johnson and seconded by Mr. Barter that the Board approve Mr. Emad Badiee for licensure, and that his name be added to the list of those to be included in the minutes on **Attachment #1**. MOTION CARRIED 9-0.

The Board reviewed the professional engineer licensure application of Edward Larsen Styskel and made the following motion:

20-010. IT WAS MOVED by Mr. Johnson and seconded by Mr. Averrett that the Board deny for licensure the application of Mr. Edward Larsen Styskel. MOTION CARRIED 9-0.

The Board previously authorized the Executive Director to approve applications for licensure, intern certification, and examinations if the application is in order and all requirements have been met. Applications of those applying for Professional Engineer licensure by comity since September 9-10, 2019, as provided by Section 34-11-4(1)(b) of the Licensure Law, were considered.

Applications of those applying for Professional Engineer licensure by examination since September 9-10, 2019, as provided by Section 34-11-4(1)a and b, of the Licensure Law having previously passed the FE Examination in Alabama or in another jurisdiction, were considered.

Applications of those applying for Engineer Intern certification since September 9-10, 2019, as provided by Section 34-11-4(2) of the Licensure Law, were considered.

Applications of those applying for Professional Land Surveyor licensure since September 9-10, 2019, as provided by Section 34-11-4(3)a and b of the Licensure Law, were considered.

Applications of those applying for Professional Land Surveyor licensure since the September 9-10, 2019, having previously passed the Fundamentals of Land Surveying Examination and the Principles and Practice of Land Surveying Examination in Alabama or in another jurisdiction were considered and were approved to take the Alabama Land Surveying Standards, History, and Law Examination.

20-011. IT WAS MOVED by Mr. Barter and seconded by Ms. Adams-Morales that the Board ratify the approval of licenses issued since the September 9-10, 2019, meeting and the list of those be included in the minutes on **Attachment #1**. MOTION CARRIED 9-0.

20-012. IT WAS MOVED by Mr. Barter and seconded by Ms. Adams-Morales that the Board ratify the approval of Intern Certifications issued since the September 9-10, 2019, Board Meeting and that the list of those be included in the minutes on **Attachment #2**. MOTION CARRIED 9-0.

20-013. IT WAS MOVED by Mr. Barter and seconded by Ms. Adams-Morales that the Board ratify the approval of exam applicants approved since the September 9-10, 2019, Board Meeting and approve for examination the applicants listed on **Attachment #3**. MOTION CARRIED 9-0.

20-014. IT WAS MOVED by Mr. Barter and seconded by Ms. Adams-Morales to deny for licensure the application of Timothy James Dow, Leonard Bruce Gregory II and Lee Richard Lentz. MOTION CARRIED 9-0.

#### **CERTIFICATES OF AUTHORIZATION** – Ms. Adams-Morales, Advisor

The Board authorizes the Executive Director to issue certificates of authorization to applying firms if the application is in order and all requirements have been met. A list of the certificate of authorizations issued since the September 9-10, 2019, Board Meeting were reviewed.

20-015. IT WAS MOVED by Ms. Adams-Morales and seconded by Mr. Barter that the Board ratify the approval of the Engineering and Land Surveying Certificates of Authorization issued since the September 9-10, 2019, Board Meeting and the list of those issued be included in the minutes on **Attachment #4**. MOTION CARRIED 9-0.

The Board reviewed a request from Mr. Bolaji Kukoyi of Dynamic Civil Solutions regarding some questions he had about opening a branch office in Huntsville, Alabama. The questions were: 1. Would the Huntsville location need to be identified on their CA and have a resident responsible charge if only used as a field office? 2. At what point would a field office need to be identified as an actual engineering office? 3. Would it be acceptable to include the Huntsville location on business cards and inform clients of that location?

The Board determined to advise Mr. Kukoyi that his firm would need to meet the certificate of authorization requirements for any branch office he wished to open.

**LAW ENFORCEMENT** – Ms. Elaine B. Walton, Advisor

The Board reviewed the status of the files pending with the Investigators, and the Investigative Committee. The Board was briefed on the 2018-2019 statistics.

The Board reviewed pending cases presented by the investigative committees to accept, modify, or reject the recommended actions. The cases were discussed in a sanitized format to avoid compromising due process for the Respondent in the event the Board determined another course of action.

20-016. IT WAS MOVED by Mr. Johnson and seconded by Ms. Adams-Morales the Board accept the recommendations of the investigative committee and close Case 2019-23 with no action. MOTION CARRIED 8-0 with Mr. Vaughn recused.

20-017. IT WAS MOVED by Mr. Johnson and seconded by Ms. Walton that the Board accept the recommendations of the investigative committee and close Case 2019-24 with no action. MOTION CARRIED 8-0 with Mr. Breighner recused.

20-018. IT WAS MOVED by Mr. Barter and seconded by Mr. Breighner that the Board accept the recommendations of the investigative committee and close Case 2019-25 with a letter of caution. MOTION CARRIED 8-0 with Mr. Johnson recused.

20-019. IT WAS MOVED by Mr. Johnson and seconded by Ms. Walton that the Board accept the recommendations of the investigative committee and close Case 2019-28 with no action. MOTION CARRIED 7-0 with Mr. Averrett abstaining, and Ms. Adams-Morales recused.

The Board generically discussed Case 2019-31 and determined that it required additional investigation. It was referred back to the investigative committee.

At 1:40 pm the Board determined to go into Executive Session to deliberate the recommendations of Administrative Law Judge Jerry Wood regarding a disciplinary hearing held on September 9, 2019. Attorney Ben Albritton confirmed that it was permissible for the Board to enter Executive Session for this matter.

20-020. IT WAS MOVED by Mr. Barter and seconded by Mr. Breighner that the Board go into executive session for thirty minutes to deliberate. MOTION CARRIED 9-0 with Mr. Johnson, Ms. Walton, Ms. Baldwin, Mr. Averrett, Mr. Whorton, Mr. Vaughn, Mr. Barter, Ms. Adams-Morales and Mr. Breighner voting for the executive session. Ms. Adams-Morales was recused from the session.

The Board exited executive session at 2:25 pm and made the following motion.

20-021. IT WAS MOVED by Mr. Barter and seconded by Mr. Johnson that the Board reject the recommendations of ALJ Jerry Wood and develop an Order that contained its findings of fact, conclusions of law, and guilt determination thereby closing Case 2018-25-B. MOTION CARRIED 8-0 with Ms. Adams-Morales recused.

20-022. IT WAS MOVED by Mr. Johnson and seconded by Mr. Averrett that the Board accept the proposed consent order and issue a Final Order thereby closing Case 2019-22. MOTION CARRIED 8-0 with Mr. Whorton recused.

The Board was briefed on current Outreach activities.

**EXECUTIVE DIRECTOR'S REPORT**

The Board was briefed on the status of the online renewals, the scheduled property inventory of items over \$500 in value, and the dismissal of Case 2018-13-B by the Montgomery County Circuit Court.

**CORRESPONDENCE**

The Board reviewed requests from Michael J.R. Moran, Ira M. Rubin, James S. Fitzgerald Jr., Everett W. Glover, Frank Tottorici, David W. Strain Sr., Iosif Elkunovich Shlyubsky, Jonnie C. Peng Ho, and Craig D. Moritz that they be granted the right to use the title "Professional Engineer, Retired."

20-023. IT WAS MOVED by Mr. Barter and seconded by Mr. Breighner that the Board grant approval for the individuals requesting to use the title "Professional Engineer, Retired". MOTION CARRIED 9-0.

The Board reviewed correspondence submitted by Mr. Mark Norris of the organization, "Mobile Area Council of Engineers" (MACE), that requested the Board allow the organization's name to contain the word "Engineers" without having to meet the certificate of authorization requirements. The Board determined the word "Engineers" in the firm name did not tend to convey that the organization was offering engineering services.

20-024. IT WAS MOVED by Mr. Barter and seconded by Ms. Adams-Morales that the Board allow the firm Mobile Area Council of Engineers, to use the term "Engineering" in its name without having to meet the certificate of authorization requirements. MOTION CARRIED 9-0.

The Board reviewed correspondence submitted by Mr. B. Ronan Johnson for the organization, "C & R Tool & Engineering", that requested the Board allow the organization's name to contain the word "Engineering" without having to meet the certificate of authorization requirements. The Board determined the word "Engineering" in the firm name tended to convey that the organization was offering engineering services.

20-025. IT WAS MOVED by Mr. Barter and seconded by Mr. Averrett that the Board deny "C & R Tool & Engineering's request to use the word "Engineering" in its name without having to meet the certificate of authorization requirements. MOTION CARRIED 9-0.

The Board reviewed documentation forwarded from the Governor's office regarding recommendations from the National Transportation Safety Board (NTSB) in reference to the utility exemption contained in the Code of Alabama. The Board determined to draft a letter to the Governor that stated it generally supported the removal of the utility exemption; but recognized that it would require a law change and the cooperation of the Public Service Commission.

The Board discussed Action Item 2018-01 regarding remote supervision, and Action Item 2019-01 related to drafting a letter to be sent to County GIS Offices. It was determined that the working group would meet to discuss the remote supervision issue, and that Mr. Breighner and Mr. Johnson would provide edits for the draft letter in Action Item 2019-01.

**NEW BUSINESS**

The Board discussed adding discipline specific licensing for Structural and Construction engineering. It was determined that the item would be placed on the January 14, 2020, meeting agenda which would allow Members time to study the issue.

**CLOSING REMARKS**


