

**ALABAMA BOARD OF LICENSURE FOR
PROFESSIONAL ENGINEERS AND LAND SURVEYORS
MINUTES - MAY 18, 2021
Montgomery, Alabama**

The Alabama Board of Licensure for Professional Engineers and Land Surveyors was established by legislative action in 1935. Its charter is to protect the public by helping to safeguard life, health, and property, and to promote the public welfare by providing for the licensing and regulation of persons in the practices of engineering and land surveying. This purpose is achieved through the establishment of minimum qualifications for entry into the professions of engineering and land surveying, through the adoption of rules defining and delineating unlawful or unethical conduct, and through swift and effective discipline for those individuals or entities who violate the applicable laws or rules.

Board meeting notices are posted on the Open Meetings area of the website of the Secretary of State, and the Board's website under Dates and Deadlines. The public can also attend the meeting virtually via the "Board Meeting" link on the website.

Chair Adams-Morales called the meeting to order at 8:08 A.M., Tuesday May 18, 2021, at the Board Office in Montgomery, Alabama. She noted there was a quorum of Members present and the meeting began with the pledge of allegiance and a prayer. The following Members and Staff were in attendance.

The proposed meeting agenda was reviewed.

21-060. IT WAS MOVED by Mr. Johnson and seconded by Mr. Averrett to adopt the agenda as proposed. MOTION CARRIED 9-0.

Minutes of the meeting of the 2020-2021 Board held on March 16, 2021, were reviewed.

21-061. IT WAS MOVED by Ms. Baldwin and seconded by Ms. Walton that the minutes of the meeting held March 16, 2021, be approved. MOTION CARRIED 9-0.

APPLICATIONS – Mr. Nathan G. Johnson, Advisor

The Board previously authorized the Executive Director to approve applications for licensure, intern certification, and examinations if the application is in order and all requirements have been met.

Applications of those applying for Professional Engineer licensure since March 16, 2021, as provided by Section 34-11-4(1)a.1 and a.2, of the Licensure Law having previously passed the FE Examination in Alabama or in another jurisdiction, were considered.

Applications of those applying for Professional Engineer licensure by comity since March 16, 2021, as provided by Section 34-11-4(1)(b) of the Licensure Law, were considered.

Applications of those applying for Engineer Intern certification since March 16, 2021, as provided by Section 34-11-4(2) of the Licensure Law, were considered.

Applications of those applying for Professional Land Surveyor licensure since March 16, 2021, as provided by Section 34-11-4(3)a and b of the Licensure Law, were considered.

Applications of those applying for Professional Land Surveyor licensure since the March 16, 2021, having previously passed the Fundamentals of Land Surveying Examination and the Principles and Practice of Land Surveying Examination in Alabama or in another jurisdiction were considered and were approved to take the Alabama Land Surveying Standards, History, and Law Examination.

APPLICATION HEARINGS

Four professional engineer licensure applicants whose applications had been denied at the March 16, 2021, meeting submitted an appeal of the licensure denial and met with the Board to discuss their

applications. At the conclusion of the hearings the Board determined that it would delay its discussion until later in the meeting.

The Board reviewed a request from Robert E. Snider of Sherlock Smith and Adams (SS&A) regarding his firm's proposed remote office qualifying engineering experience procedures. Mr. Snider stated that SS&A believes working remotely provides valuable training needed as the EI learns to master the must-have skills of working away from the physical office using his/her business laptop computer and smart phone.

The Board determined to send Mr. Snider a letter advising him that the Board's policy is not to approve or disapprove a firm's procedures for the methodology used to document engineering or land surveying experience.

CERTIFICATES OF AUTHORIZATION – Ms. Adams-Morales, Advisor

The Board authorizes the Executive Director to issue certificates of authorization to applying firms if the application is in order and all requirements have been met. A list of the certificate of authorizations issued since the March 16, 2021, Board Meeting were reviewed.

21-066. IT WAS MOVED by Mr. Breighner and seconded by Mr. Robinson that the Board ratify the approval of the Engineering and Land Surveying Certificates of Authorization issued since the March 16, 2021, Board Meeting and the list of those issued be included in the minutes on **Attachment #4**. LAW ENFORCEMENT – Ms. Elaine B. Walton, Advisor

The Board reviewed the status of the files pending with the Investigators, and the Investigative Committee. The Board was briefed on the 2020-2021 statistics.

The Board discussed Mr. Vaughn's proposed Guidelines for Enforcement of Certificate of Authorization Requirements for the Investigative Committee to consider when making recommendations concerning violations. The Guidelines includes language that states: "This document is offered as guidance when preparing a consent order, and do not preclude the discretion of the Investigative Committee or the Board when determining penalties for COA violations.

The Board recessed for lunch from 11:41 AM until 12:30 PM.

LEGISLATIVE, LAW AND RULES - Randall D. Whorton

Mr. Whorton provided an update to the Board regarding discussions with Representative Harold Sanderford regarding the proposed rule change which added a Structural Engineer Roster Designation. After this discussion the Board determined to create a document that would explain its reasoning for the proposed rule change which could be placed on its website.

Mr. Whorton also briefed the Board on other legislation of interest to the Board.

FINANCE – Mr. John E. Averrett, Advisor

The monthly financial report for March and April were briefed.

EXECUTIVE DIRECTOR'S REPORT

It was briefed that the proposed rules regarding Structural Engineer Roster Designation and changes to the Certificate of Authorization Application became effective on May 17, 2021.

The Board was advised that NCEES had increased the number of attendees to three that would be allowed to physically attend the annual meeting in New Orleans, LA in August 2021. The Board determined the Executive Director would be the designated third attendee.

The Board discussed the proposed NCEES "Resolution of Cooperation," (a non-binding agreement designed to serve as guidance for member boards). The Board determined that it did not agree with the resolution's current form and would not sign it.

CORRESPONDENCE

The Board reviewed a list of individuals requesting to use the title "Professional Engineer, Retired" or "Professional Land Surveyor, Retired."
