CONSENT ORDER

Constance Hickey Scott, a licensed professional engineer (hereinafter referred to as “Respondent”) hereby stipulates and agrees, subject to approval of the Alabama Board of Licensure for Professional Engineers and Land Surveyors (hereinafter referred to as the “Board”) as follows:

STIPULATED FACTS

Respondent stipulates she received an Alabama professional engineer license (number 20872 from the Board on November 6, 1995.

Respondent stipulates she prepared electrical engineering design plans dated February 11, 2015, for the Hilton Garden Inn project in Mobile, Alabama that identify “CHS Engineering” as the Electrical Consultant for the project.

Respondent stipulates Constance Hickey Scott dba CHS Engineering received a certificate of authorization for engineering on March 27, 2015.

STIPULATED CONCLUSIONS OF LAW

Respondent admits she is subject to the provisions of Title 34, Chapter 11, Code of Alabama 1975, § 34-11-11 and the jurisdiction of the Board.

Respondent stipulates her conduct as set forth in the foregoing “Stipulated Facts” constitutes violations of Title 34 Chapter 11 Code of Alabama 1975 § 34-11-9(a)1, § 34-11-11(a)2 and the Rules of the Administrative Code § 330-X-.14-.06(a)1.

Respondent stipulates her conduct as set forth in the “Stipulated Facts” is a violation of those statutes set forth above, and she is subject to disciplinary action under Title 34, Chapter 11, Code of Alabama 1975, § 34-11-11.

STIPULATED DISPOSITION

Respondent understands this Consent Order and subsequent Final Order will be a public record and will be published on the Board’s website, in its newsletter, and in the Enforcement Exchange of the National Council for Examiners of Engineers and Surveyors (NCEES).

Respondent agrees she will not in the future violate the provisions of Title 34, Chapter 11, of the Code of Alabama, and the Rules and Regulations of the Administrative Code of the Board.

Respondent agrees to pay a one thousand dollar (\$1,000) fine to the Board via a certified check made payable to PE/PLS Fund with this signed Consent Order.

Respondent understands that failure to comply with the terms of the Consent Order could cause her professional engineer license to be revoked. Respondent further understands the matter would be presented to the Board at a regularly scheduled meeting at which he could attend and present evidence on his behalf.

Respondent understands this Consent Order is subject to the approval of the Board and has no force and effect until the Final Order based upon it is rendered by the Board.


Respondent understands in order to make a decision relative to approving this Consent Order discussions must take place between Board Members, Board Staff and Board Counsel. Respondent understands that this discussion will take place at a regularly scheduled meeting of the Board.


Respondent understands that should the Consent Order not be accepted by the Board, it is agreed that presentation to and consideration of the Consent Order by the Board shall not unfairly or illegally prejudice the Board or any of its members from further participation in or resolution of these proceedings. Likewise, if this Consent Order is not accepted, the Board shall not take into consideration the contents of this Order as evidence of an admission.

Respondent understands she has the right to seek the advice of legal counsel. Respondent also understands she has the right to a formal fact finding hearing before the Board, to compel the testimony of witnesses, to cross-examine witnesses against him, and to obtain judicial review of the Board's decision in said formal hearing, but expressly waives these rights with the execution of this Consent Order.

Respondent expressly waives all other rights to challenge or contest the validity of the Consent Order, the stipulated facts, conclusions of law, imposition of administrative action contained herein, and the Final Order of the Board incorporating the Consent Order. Respondent, for the purpose of avoiding further administrative action with respect to this cause executes this Consent Order.
