ALABAMA BOARD OF LICENSURE FOR PROFESSIONAL ENGINEERS AND LAND SURVEYORS MINUTES – JULY 20, 2021 Montgomery, Alabama

The Alabama Board of Licensure for Professional Engineers and Land Surveyors was established by legislative action in 1935. Its charter is to protect the public by helping to safeguard life, health, and property, and to promote the public welfare by providing for the licensing and regulation of persons in the practices of engineering and land surveying. This purpose is achieved through the establishment of minimum qualifications for entry into the professions of engineering and land surveying, through the adoption of rules defining and delineating unlawful or unethical conduct, and through swift and effective discipline for those individuals or entities who violate the applicable laws or rules.

Board meeting notices are posted on the Open Meetings area of the website of the Secretary of State, and the Board's website under Dates and Deadlines. The public can also attend the meeting virtually via the "Board Meeting" link on the website.

Chair Adams-Morales called the meeting to order at 8:00 A.M., Tuesday July 20, 2021, at the Board Office in Montgomery, Alabama. She noted there was a quorum of Members present and the meeting began with the pledge of allegiance and a prayer. The following Members and Staff were in attendance.

21-075. IT WAS MOVED by Mr. Averrett and seconded by Mr. Breighner that the minutes of the meeting held May 18, 2021, be approved. MOTION CARRIED 9-0.

APPLICATIONS – Mr. Nathan G. Johnson, Advisor

The Board previously authorized the Executive Director to approve applications for licensure, intern certification, and examinations if the application is in order and all requirements have been met.

Mr. Averrett provided a document to the Board regarding experience gained via remote supervision. After discussion of the document, the Board made the following motion:

21-082. IT WAS MOVED by Mr. Johnson and seconded by Mr. Vaughn to accept the following language as a guideline for applicants with experience gained from remote supervision. MOTION CARRIED 9-0.

"While it cannot be disputed that the benefits of face-to-face mentoring and supervision of engineering or land surveyor interns cannot be overemphasized; it is also recognized that a certain degree of benefit can be realized through mentoring and supervision by using electronic communication platforms. With the need to conduct business not only in person, but virtual interaction with business clients becoming more acceptable and necessary in today's business climate, the use of technological communication tools have become a necessity in modern business interactions. This is true not only for client interactions, but it is also essential for employee communication and training.

BELS will recognize remote supervision of engineers and land surveyors, but only on a case-by-case basis. Documented evidence must be provided to the board that clearly outlines the remote supervision methodology utilized to guide the engineering and/or land surveyor intern towards progressive knowledge and responsibility. An active formal training and supervision plan must be developed by a firm wishing to employ remote supervision techniques, that describes, in detail, the methodologies to be employed and the frequency of virtual contact between the engineering and/or land surveyor intern and the supervisor. Written records should be maintained by the consulting firm, which may be requested by BELS to verify intern supervision."

CERTIFICATES OF AUTHORIZATION – Ms. Adams-Morales, Advisor

The Board authorizes the Executive Director to issue certificates of authorization to applying firms if the application is in order and all requirements have been met. A list of the certificate of authorizations issued since the May 18, 2021, Board Meeting were reviewed.

The Board reviewed the status of the files pending with the Investigators, and the Investigative Committee. The Board was briefed on the 2020-2021 statistics.

The Board discussed pending cases presented by the investigative committees to accept, modify, or reject the recommended actions. The cases were discussed in a sanitized format to avoid compromising due process for the Respondent in the event the Board determined another course of action.
