

**ALABAMA BOARD OF LICENSURE FOR  
PROFESSIONAL ENGINEERS AND LAND SURVEYORS  
MINUTES – MAY 19, 2022  
Montgomery, Alabama**

The Alabama Board of Licensure for Professional Engineers and Land Surveyors was established by legislative action in 1935. Its charter is to protect the public by helping to safeguard life, health, and property, and to promote the public welfare by providing for the licensing and regulation of persons in the practices of engineering and land surveying. This purpose is achieved through the establishment of minimum qualifications for entry into the professions of engineering and land surveying, through the adoption of rules defining and delineating unlawful or unethical conduct, and through swift and effective discipline for those individuals or entities who violate the applicable laws or rules.

Board meeting notices are posted on the Open Meetings area of the website of the Secretary of State, and the Board’s website under Dates and Deadlines. The public can also attend the meeting virtually via the “Board Meeting” link on the website.

Chair Breighner called the meeting to order at 8:00 A.M., Thursday May 19, 2022, at the Board Office in Montgomery, Alabama. He noted there was a quorum of Members present and the meeting began with the pledge of allegiance and a prayer. The following Members and Staff were in attendance.

The proposed meeting agenda was reviewed.

22-049. IT WAS MOVED by Mr. Vaughn and seconded by Mr. Robinson to adopt the agenda as proposed. MOTION CARRIED 8-0.

Minutes of the meeting of the 2021-2022 Board held on March 8, 2022, were reviewed.

22-050. IT WAS MOVED by Mr. Johnson and seconded by Mr. Averrett that the minutes of the meeting held March 8, 2022, be approved as amended. MOTION CARRIED 8-0.

The Board's certificate of authorization sub-committee presented its findings to the Board, and it was determined that current policies would remain in effect. It was further determined that a definition of a "Home Office" and a "Branch Office" would be placed in the Administrative Code through the rule making process at a later date.

#### **APPLICATIONS** – Mr. Nathan G. Johnson, Advisor

Board staff asked for guidance regarding applications in which the individual fails to answer a question on the application completely or truthfully. The Board gave general guidance and instructed that this type of issue be evaluated on a case-by-case basis.

The Board previously authorized the Executive Director to approve applications for licensure, intern certification, and examinations if the application is in order and all requirements have been met.

Applications of those applying for Professional Engineer licensure since March 8, 2022, as provided by Section 34-11-4(1)a.1 and a.2, of the Licensure Law having previously passed the FE Examination in Alabama or in another jurisdiction, were considered.

Applications of those applying for Professional Engineer licensure by comity since March 8, 2022, as provided by Section 34-11-4(1)(b) of the Licensure Law, were considered.

Applications of those applying for Engineer Intern certification since March 8, 2022, as provided by Section 34-11-4(2) of the Licensure Law, were considered.

Applications of those applying for Professional Land Surveyor licensure since March 8, 2022, as provided by Section 34-11-4(3)a and b of the Licensure Law, were considered.

22-051. IT WAS MOVED by Mr. Vaughn and seconded by Ms. Helen Adams-Morales that the Board ratify the approval of licenses issued since the March 8, 2022, meeting and the list of those be included in the minutes on **Attachment #1**. MOTION CARRIED 8-0.

22-052. IT WAS MOVED by Mr. Vaughn and seconded by Ms. Helen Adams-Morales to deny for licensure the professional engineer application of Dewey Lenville Bocook, Jr., William Channing Blackwell, and Lindell Donald Albaugh. MOTION CARRIED 8-0.

22-053. WAS MOVED by Mr. Vaughn and seconded by Ms. Helen Adams-Morales that the Board ratify the approval of Intern Certifications issued since the March 8, 2022, Board Meeting and that the list of those be included in the minutes on **Attachment #2**. MOTION CARRIED 8-0.

22-054. WAS MOVED by Mr. Vaughn and seconded by Ms. Helen Adams-Morales that the Board ratify the approval of exam applicants since the March 8, 2022, Board Meeting and approve for examination applicants listed on **Attachment #3**. MOTION CARRIED 8-0.

**CERTIFICATES OF AUTHORIZATION** – Ms. Adams-Morales, Advisor

The Board authorizes the Executive Director to issue certificates of authorization to applying firms if the application is in order and all requirements have been met. A list of the certificate of authorizations issued since the March 8, 2022, Board Meeting were reviewed.

22-055. IT WAS MOVED by Ms. Adams-Morales and seconded by Mr. Averrett that the Board ratify the approval of the Engineering and Land Surveying Certificates of Authorization issued since the March 8, 2022, Board Meeting and the list of those issued be included in the minutes on **Attachment #4**. MOTION CARRIED 8-0.

The Board reviewed a request from Mr. Hayden Kaiser that him and/or his partner be allowed to remotely supervise an employee in an office located in Foley, Alabama in order to qualify for a certificate of authorization which would include that office location.

As part of the discussion the Board also reviewed its policy on the remote supervision of individuals wishing to gain experience to meet licensure requirements and determined to make a minor revision to its current policy. The updated policy will be located on the Board's website on the "Applications" webpage.

22-056. IT WAS MOVED by Mr. Johnson and seconded by Mr. Robinson to deny the certificate of authorization application of AXIS Engineering Group until the firm could employ a licensed professional engineer for the Foley, Alabama office location, and The Board would not pre-approve a Remote Supervision Plan. MOTION CARRIED 8-0.

**LAW ENFORCEMENT** – Ms. Elaine B. Walton, Advisor

The Board was briefed on the 2021-2022 enforcement statistics and reviewed the status of the files pending with the Investigators, and the Investigative Committee. The cases were discussed in a sanitized format to avoid compromising due process for the Respondent in the event the Board determined another course of action.

22-057. IT WAS MOVED by Mr. Averrett and seconded by Ms. Walton that the Board accept the recommendation of the investigative committee and close Case 2021-21 with no action. MOTION CARRIED 7-0 with Ms. Adams-Morales recused.

22-058. IT WAS MOVED by Mr. Robinson and seconded by Ms. Walton that the Board accept the recommendation of the Administrative Law Judge and issue a Final Order thereby closing Case 2021-30. MOTION CARRIED 8-0.

22-059. IT WAS MOVED by Ms. Adams-Morales and seconded by Mr. Robinson that the Board accept the proposed Consent Order and issue a Final Order thereby closing Case 2022-02. MOTION CARRIED 7-0 with Ms. Walton recused.

22-060. IT WAS MOVED by Mr. Johnson and seconded by Ms. Adams-Morales that the Board accept the proposed Consent Order and issue a Final Order thereby closing Case 2022-08 and 2022-09. MOTION CARRIED 7-1 with Mr. Robinson voting against the motion.

The Board recessed at 9:35 AM in order to appear before the Sunset Committee in Room 200 of the Alabama State House for a meeting scheduled for 10:30 AM.

The Board met with the Sunset Committee and presented information and answered questions related to its operations. The meeting concluded at 11:00 AM.

The Board recessed for lunch at 11:01 AM; and returned from lunch at 12:00 PM. The Board continued its review of enforcement cases.

22-061. IT WAS MOVED by Mr. Averrett and seconded by Mr. Robinson that the Board accept the recommendation of the investigative committee and close Case 2022-12 with a letter of caution. MOTION CARRIED 7-0 with Mr. Breighner recused.

22-062. IT WAS MOVED by Mr. Johnson and seconded by Ms. Adams-Morales that the Board accept the recommendation of the investigative committee and close Case 2022-17 with a letter of caution. MOTION CARRIED 6-0 with Mr. Robinson abstaining and Ms. Walton recused.

22-063. IT WAS MOVED by Mr. Vaughn and seconded by Mr. Averrett that the Board accept the proposed Consent Order and issue a Final Order thereby closing Case 2022-18. MOTION CARRIED 7-0 with Mr. Breighner recused.

22-064. IT WAS MOVED by Mr. Johnson and seconded by Ms. Adams-Morales that the Board accept the recommendation of the investigative committee and close Case 2022-19 with a letter of caution. MOTION CARRIED 6-0 with Mr. Whorton abstaining and Mr. Vaughn recused.

22-065. IT WAS MOVED by Mr. Averrett and seconded by Mr. Vaughn that the Board accept the recommendation of the investigative committee and close Case 2021-21 with no action. MOTION CARRIED 8-0.

22-066. IT WAS MOVED by Mr. Vaughn and seconded by Mr. Johnson that the Board accept the recommendation of the investigative committee and close Case 2022-04 with a letter of caution. MOTION CARRIED 6-0 with Ms. Adams-Morales abstaining and Mr. Breighner recused.

**LEGISLATION** – Mr. Randy Whorton, Advisor

The Board was briefed on the need to develop a revision to an administrative rule to comply with ACT #2022-92 which passed in the 2022 Legislative Session. Proposed rule changes will be reviewed at the August 2, 2022, meeting.

**FINANCE** – Mr. John E. Averrett, Advisor

The monthly financial reports for March, April and May 2022 were briefed.

**PERSONNEL** – Mr. Randy Whorton, Advisor

The Board discussed the performance of Executive Director Rick Huett, and made the following motion:

22-067. IT WAS MOVED by Mr. Whorton and seconded by Mr. Vaughn that the Board approve a 5% raise for Executive Director Rick Huett. MOTION CARRIED 8-0.

## **EXECUTIVE DIRECTOR'S REPORT**

The Board was briefed on changes to the NCEES Structural Exam Format, and the need to consider conducting a review of the State Specific Exam since several years had passed since the last review.

The Board was also briefed on the need for additional professional engineer and professional land surveyor technical advisors.

## **CORRESPONDENCE**

The Board reviewed a list of individuals requesting to use the title "Professional Engineer, Retired" or "Professional Land Surveyor, Retired."

22-068. IT WAS MOVED by Mr. Robinson and seconded by Ms. Adams-Morales that the Board ratify the approval of the individuals requesting to use the title "Professional Engineer, Retired" or Professional Land Surveyor, Retired". MOTION CARRIED 8-0.

The Board reviewed a request from John C. Pittaluga which asked that the firm "Engineered Control Systems Inc," be allowed to keep the word "Engineered" in its name without having to meet the Certificate of Authorization requirements. After review of the information submitted by Mr. Pittaluga, the Code of Alabama and its Rules and Regulations the Board made the following motion:

22-070. IT WAS MOVED by Mr. Vaughn and seconded by Mr. Robinson that "Engineered Control Systems Inc" be required to meet the certificate of authorization requirements in order to use the term "Engineered" in its name. MOTION CARRIED 8-0.

The Board awarded Ms. Adams Morales a plaque and a Senate Resolution in recognition of her Board service, and her contributions to the engineering profession.

At 2:00 PM Ms. Adams-Morales left the meeting.

The Board reviewed a request from professional land surveyor Mark Peavy inquiring if a certificate of authorization would be required for Jefferson County – if the County acquired property and wished to place its name on a property boundary corner. After review and discussion, the Board determined to inform Mr. Peavy that a professional land surveyor number, or a certificate of authorization number, must appear on property boundary monumentation, and the boundary survey produced must comply with the Standards of Practice for Land Surveying in Alabama.




review of the information submitted by Mr. Bender, the Code of Alabama and its Rules and Regulations the Board made the following motion:






