

**ALABAMA BOARD OF LICENSURE FOR
PROFESSIONAL ENGINEERS AND LAND SURVEYORS
MINUTES – NOVEMBER 15, 2022
Montgomery, Alabama**

The Alabama Board of Licensure for Professional Engineers and Land Surveyors was established by legislative action in 1935. Its charter is to protect the public by helping to safeguard life, health, and property, and to promote the public welfare by providing for the licensing and regulation of persons in the practices of engineering and land surveying. This purpose is achieved through the establishment of minimum qualifications for entry into the professions of engineering and land surveying, through the adoption of rules defining and delineating unlawful or unethical conduct, and through swift and effective discipline for those individuals or entities who violate the applicable laws or rules.

Board meeting notices are posted on the Open Meetings area of the website of the Secretary of State, and the Board’s website under Dates and Deadlines. The public can also attend the meeting virtually via the “Board Meeting” link on the website.

Chair Vaughn called the meeting to order at 8:00 A.M., Tuesday November 15, 2022, at the Board Office in Montgomery, Alabama. He noted there was a quorum of Members present and the meeting began with the pledge of allegiance and a prayer. The following Members and Staff were in attendance.

Minutes of the meeting of the 2021-2022 Board held on September 20, 2022, were reviewed.

23-001. IT WAS MOVED by Mr. Averrett and seconded by Mr. Breighner that the minutes of the meeting held September 20, 2022, be approved. MOTION CARRIED 8-0.

Minutes of the meeting of the 2022-2023 Board held on October 26, 2022, were reviewed.

23-002. IT WAS MOVED by Mr. Averrett and seconded by Mr. Robinson that the minutes of the meeting held October 26, 2022, be approved. MOTION CARRIED 8-0.

APPLICATIONS – Mr. Nathan G. Johnson, Advisor

Board staff asked for guidance regarding applications in which the individual fails to answer a question on the application completely or truthfully. The Board gave general guidance and instructed that this type of issue be evaluated on a case-by-case basis.

The Board previously authorized the Executive Director to approve applications for licensure, intern certification, and examinations if the application is in order and all requirements have been met.

Applications of those applying for Professional Engineer licensure since September 20, 2022, as provided by Section 34-11-4(1)a.1 and a.2, of the Licensure Law having previously passed the FE Examination in Alabama or in another jurisdiction, were considered.

Applications of those applying for Professional Engineer licensure by comity since September 20, 2022, as provided by Section 34-11-4(1)(b) of the Licensure Law, were considered.

Applications of those applying for Intern certification since September 20, 2022, as provided by Section 34-11-4(2) of the Licensure Law, were considered.

Applications of those applying for Professional Land Surveyor licensure since September 20, 2022, as provided by Section 34-11-4(3)a and b of the Licensure Law, were considered.

23-005. IT WAS MOVED by Mr. Breighner and seconded by Ms. Walton to deny for licensure the professional engineer application of John Franklin Germ, Matthew Allen Houdeshell, Eric Woodrow Bradford, Christopher John Constantine, and Tanya Nicole Walkenbach. MOTION CARRIED 8-0.

23-006. WAS MOVED by Mr. Breighner and seconded by Ms. Walton that the Board ratify the approval of Intern Certifications issued since the September 20, 2022, Board Meeting and that the list of those be included in the minutes on **Attachment #2**. MOTION CARRIED 8-0.

23-007. WAS MOVED by Mr. Breighner and seconded by Ms. Walton that the Board ratify the approval of exam applicants since the September 20, 2022, Board Meeting and approve for examination the applicants listed on **Attachment #3**. MOTION CARRIED 8-0.

The Board reviewed correspondence from Mr. Jeff Mangas requesting that his BS technology degree with concentrations in Construction Operations and Design Analysis be considered as an engineering technology degree. The Board determined to advise Mr. Mangas that it would not consider the degree as an engineering technology degree since that was not indicated on the transcript.

CERTIFICATES OF AUTHORIZATION – Mr. James C. Pegues, Advisor

The Board authorizes the Executive Director to issue certificates of authorization to applying firms if the application is in order and all requirements have been met. A list of the certificate of authorizations issued since the September 20, 2022, Board Meeting were reviewed.

23-008. IT WAS MOVED by Mr. Averrett and seconded by Mr. Robinson that the Board ratify the approval of the Engineering and Land Surveying Certificates of Authorization issued since the September 20, 2022, Board Meeting and the list of those issued be included in the minutes on **Attachment #4**. The Board reviewed correspondence from Mr. Jason Robbins requesting that Motz Consulting Engineers, Inc be allowed to keep the word “Engineers” in its name without having to meet the Certificate of Authorization requirements. After this review the Board made the following motion:

LAW ENFORCEMENT – Ms. Elaine B. Walton, Advisor

The Board was briefed on the 2021-2022 enforcement statistics and reviewed the status of the files pending with the Investigators, and the Investigative Committee. The cases were discussed in a sanitized format to avoid compromising due process for the Respondent in the event the Board determined another course of action.

FINANCE – Mr. John E. Averrett, Advisor

The monthly financial reports for August and September 2022 were briefed.

PUBLIC HEARING

At 9 am, the Board began its advertised public hearing regarding proposed administrative code rule changes. No requests to speak were received and the Board reviewed each proposed rule change and the written comments it received regarding each rule. After its review the Board made the following motion:

Sections, 330-X-2-.01, 330-X-3-.01, 330-X-3-.03, 330-X-4 FEES, 330-X-5-.01, 330-X-6-.01, 330-X-7-.02, 330-X-8-.02, 330-X-8-.07, 330-X-8-.07.01, 330-X-13-.01, 330-X-13-.02 and 330-X-16-.01.

EXECUTIVE DIRECTOR'S REPORT

The Board discussed creating a volunteer task force to review the State Specific Surveying Exam. The intent is to start the review in February 2023.

The Board reviewed correspondence from NCEES inquiring which Board Members or Associate Members would serve as the NCEES funded delegates for the NCEES Southern Zone meeting scheduled for April 2023. After discussion, the Board determined it would designate Board Staff Members Bonnie Kelly, Robert Herbert, and Board Counsel Benjamin Albritton as its funded delegates.

PLS LICENSURE REQUIREMENTS DISCUSSION

The Board was provided an update regarding a request from Senator Andrew Jones to consider a professional land surveyor licensure pathway that would allow an Associate Degree, plus 30 hours of surveying courses, to meet the education requirement.

The Board determined to send a letter to Senator Jones in response to his request.

QUALIFICATION BASED SELECTION

Board Member Randy Whorton provided a presentation regarding the recent changes to the ALDOT procurement process and the impact those changes had on the qualification-based selection

requirements in the Board's statute. He also discussed the impact Act 2021-296 had on the procurement process for State funded projects. The Board requested Mr. Whorton to draft a short letter regarding the implications of Act 2021-296 on qualification-based selection.


CORRESPONDENCE

The Board reviewed a list of individuals requesting to use the title "Professional Engineer, Retired" or "Professional Land Surveyor, Retired."




ADJOURN TIME
