# ALABAMA BOARD OF LICENSURE FOR PROFESSIONAL ENGINEERS AND LAND SURVEYORS MINUTES – MARCH 28, 2023

Montgomery, Alabama

The Alabama Board of Licensure for Professional Engineers and Land Surveyors was established by legislative action in 1935. Its charter is to protect the public by helping to safeguard life, health, and property, and to promote the public welfare by providing for the licensing and regulation of persons in the practices of engineering and land surveying. This purpose is achieved through the establishment of minimum qualifications for entry into the professions of engineering and land surveying, through the adoption of rules defining and delineating unlawful or unethical conduct, and through swift and effective discipline for those individuals or entities who violate the applicable laws or rules.

Board meeting notices are posted on the Open Meetings area of the website of the Secretary of State, and the Board's website under Dates and Deadlines. The public can also attend the meeting virtually via the "Board Meeting" link on the website.

Chair Vaughn called the meeting to order at 8:00 A.M., Tuesday March 28, 2023, at the Board Office in Montgomery, Alabama. He noted there was a quorum of Members present and the meeting began with the pledge of allegiance and a prayer. The following Members and Staff were in attendance.

Mr. Whorton briefed the Board on Bills filed in the current Legislative Session that the Board will be monitoring.

#### **EXECUTIVE DIRECTOR'S REPORT**

The Board was briefed on the requirement to complete the Ethics Statement of Economic Interest Form prior to the deadline, about the recent Governor's Executive Orders, and the need to identify funded delegates to the NCEES annual meeting in August.

#### **CORRESPONDENCE**

The Board reviewed a list of individuals requesting to use the title "Professional Engineer, Retired" or "Professional Land Surveyor, Retired."

23-069. IT WAS MOVED by Mr. Johnson and seconded by Mr. Breighner that the Board ratify the approval of the individuals requesting to use the title "Professional Engineer, Retired" or Professional Land Surveyor, Retired". MOTION CARRIED 9-0.

The Board reviewed correspondence from Tony and Shree Meade requesting that "South Alabama Cleaning Services dba Pressure Washing Engineers" be allowed to keep the word "Engineers" in its name without having to meet the Certificate of Authorization requirements. After this review the Board made the following motion:

23-070. IT WAS MOVED by Ms. Baldwin and seconded by Mr. Robinson that in order for "South Alabama Cleaning Services dba Pressure Washing Engineers" to use the term "Engineers" in its name it must meet the Certificate of Authorization requirements. MOTION CARRIED 9-0.

The Board met with Dr. John T. Wade and Mr. Timothy G. Morris to discuss the activities performed by Fire Protection Engineers and Architects on projects. Dr. Wade and Mr. Morris requested the Board to issue formal opinions regarding the following: (1) A duly registered engineer can execute designs on the subjects noted in the NCEES FP PE Exam specifications and (2) that a "duly registered Fire Protection Engineer can fully practice fire protections engineering for any occupancy, in a structure of any material, whether the building is intended for residential, commercial, government, or industrial use." After the discussion the Board determined to advise Dr. Wade and Mr. Morris that it would take no action on the request.

The Board discussed correspondence it received from Mr. Gary April of the State of Alabama Engineering Hall of Fame. Mr. April indicated that he was interested in methods to bring the two agencies together in ways that reflect the respective mission of each organization. The Board determined that it would include information related to the Engineering Hall of Fame in its Newsletter.

The Board went to lunch at 12:05. Returned at 12:55 PM.

#### APPLICATION HEARING

Gheorghe Meyer, whose professional engineer licensure application was denied at the January 18, 2023, meeting met with the Board electronically at 1 PM. Mr. Meyer provided information regarding his application and answered all Board Member questions.

#### APPLICATION DISCUSSION

Mark Jeffrey Boyles and his attorney Winston Grow, met with the Board at 1:30 PM. Mr. Boyles and Mr. Grow provided information regarding his application and answered all Board Member questions.
