

**ALABAMA BOARD OF LICENSURE FOR
PROFESSIONAL ENGINEERS AND LAND SURVEYORS
MINUTES – MAY 24, 2023
Montgomery, Alabama**

The Alabama Board of Licensure for Professional Engineers and Land Surveyors was established by legislative action in 1935. Its charter is to protect the public by helping to safeguard life, health, and property, and to promote the public welfare by providing for the licensing and regulation of persons in the practices of engineering and land surveying. This purpose is achieved through the establishment of minimum qualifications for entry into the professions of engineering and land surveying, through the adoption of rules defining and delineating unlawful or unethical conduct, and through swift and effective discipline for those individuals or entities who violate the applicable laws or rules.

Board meeting notices are posted on the Open Meetings area of the website of the Secretary of State, and the Board’s website under Dates and Deadlines. The public can also attend the meeting virtually via the “Board Meeting” link on the website.

Chair Vaughn called the meeting to order at 8:00 A.M., Wednesday May 24, 2023, at the Board Office in Montgomery, Alabama. He noted there was a quorum of Members present and the meeting began with the pledge of allegiance and a prayer. The following Members and Staff were in attendance.

The proposed meeting agenda was reviewed.

23-075. IT WAS MOVED by Mr. Averrett and seconded by Mr. Pegues to adopt the agenda as proposed. MOTION CARRIED 9-0.

Minutes of the meeting of the 2022-2023 Board held on March 28, 2023, were reviewed.

23-076. IT WAS MOVED by Ms. Baldwin and seconded by Mr. Robinson that the minutes of the meeting held March 28, 2023, be approved. MOTION CARRIED 9-0.

APPLICATIONS – Mr. Nathan G. Johnson, Advisor

The Board previously authorized the Executive Director to approve applications for licensure, intern certification, and examinations if the application is in order and all requirements have been met.

Applications of those applying for Professional Engineer licensure since March 28, 2023, as provided by Section 34-11-4(1)a.1 and a.2, of the Licensure Law having previously passed the FE Examination in Alabama or in another jurisdiction, were considered.

Applications of those applying for Professional Engineer licensure by comity since March 28, 2023, as provided by Section 34-11-4(1)(b) of the Licensure Law, were considered.

Applications of those applying for Intern certification since March 28, 2023, as provided by Section 34-11-4(2) of the Licensure Law, were considered.

Applications of those applying for Professional Land Surveyor licensure since March 28, 2023, as provided by Section 34-11-4(3)a and b of the Licensure Law, were considered.

23-077. IT WAS MOVED by Mr. Johnson and seconded by Mr. Robinson that the Board ratify the approval of licenses issued since the March 28, 2023, meeting and the list of those be included in the minutes on **Attachment #1**. MOTION CARRIED 9-0.

23-078. IT WAS MOVED by Mr. Johnson and seconded by Mr. Breighner to approve for licensure the professional engineer application of Bryson Devon Moultry. MOTION CARRIED 7-2 with Mr. Averrett and Mr. Robinson voting No.

23-079. IT WAS MOVED by Mr. Johnson and seconded by Mr. Pegues to defer for licensure the professional engineer application of Courson Chandler Hopkins and to deny for licensure the professional engineer application of Christopher Michael Jenkins, George Cory Calkins, William Michael Bailey Jr., Saul Arana Camarena, Craig Alan Schrader, and Brain Adam Poelti. MOTION CARRIED 9-0.

23-080. IT WAS MOVED by Mr. Johnson and seconded by Mr. Whorton that the Board ratify the approval of exam applicants since the March 28, 2023, Board Meeting and approve for examination the applicants listed on **Attachment #2**. MOTION CARRIED 9-0.

23-081. IT WAS MOVED by Mr. Johnson and seconded by Mr. Whorton that the Board ratify the approval of Intern Certifications issued since the March 28, 2023, Board Meeting and that the list of those be included in the minutes on **Attachment #3**. MOTION CARRIED 9-0.

Luke Mathias, an applicant for professional land surveyor licensure met with the Board virtually at 9 am to discuss the requirements for licensure. After the discussion Mr. Mathias was advised that (1) three of his five references must be licensed as a professional land surveyor and have knowledge of his work, (2) that he could not use experience he had used for his professional engineer license on his professional land surveyor application, and (3) he could use experience verified by a licensed professional land surveyor that he acquired as an intern.

APPLICATION HEARING

Mark J. Boyles whose professional engineer licensure application was denied at the March 28, 2023, meeting, met with the Board at 9:40 AM. Mr. Boyles provided information regarding his application and answered all Board member questions. The Board determined that it would delay its decision to later in the meeting.

Daniel Gregory Mattox whose professional engineer licensure application was denied at the March 28, 2023, meeting, met with the Board virtually at 10:35 AM. Mr. Mattox provided information regarding his application and answered all Board member questions. At the conclusion of the hearing the Board determined that it would delay its decision and give Mr. Mattox time to update the description of his work experience on his application.

CERTIFICATES OF AUTHORIZATION – Mr. James C. Pegues, Advisor

The Board authorizes the Executive Director to issue certificates of authorization to applying firms if the application is in order and all requirements have been met. A list of the certificate of authorizations issued since the March 28, 2023, Board Meeting were reviewed.

23-082. IT WAS MOVED by Mr. Whorton and seconded by Ms. Baldwin that the Board ratify the approval of the Engineering and Land Surveying Certificates of Authorization issued since the March 28, 2023, Board Meeting and the list of those issued be included in the minutes on **Attachment #4**. MOTION CARRIED 9-0.

LAW ENFORCEMENT – Ms. Elaine B. Walton, Advisor

The Board was briefed on the 2022-2023 enforcement statistics and reviewed the status of the files pending with the Investigators, and the Investigative Committee. The cases were discussed in a sanitized format to avoid compromising due process for the Respondent in the event the Board determined another course of action.

23-083. IT WAS MOVED by Mr. Robinson and seconded by Mr. Pegues that the Board accept the recommendation of the investigative committee and close Case 2023-10 with a letter of caution. MOTION CARRIED 8-0 with Ms. Baldwin recused.

23-084. IT WAS MOVED by Mr. Robinson and seconded by Mr. Breighner that the Board accept the recommendation of the investigative committee and close Case 2023-12 with a letter of caution. MOTION CARRIED 8-0 with Mr. Vaughn recused.

23-085. IT WAS MOVED by Mr. Whorton and seconded by Mr. Averrett that the Board accept the recommendation of the investigative committee and close Case 2023-14 with a letter of caution. MOTION CARRIED 8-0 with Mr. Johnson recused.

23-086. IT WAS MOVED by Mr. Breighner and seconded by Mr. Pegues that the Board accept the proposed Consent Order and issue a Final Order thereby closing Case 2023-16. MOTION CARRIED 8-0 with Mr. Johnson recused.

23-087. IT WAS MOVED by Ms. Baldwin and seconded by Mr. Johnson that the Board accept the recommendation of the investigative committee and close Case 2023-22 with no action. MOTION CARRIED 8-0 with Mr. Vaughn recused.

FINANCE – Mr. John E. Averrett, Advisor

The monthly financial reports for February 2023 and March 2023 were briefed.

LEGISLATION – Mr. Randy Whorton, Advisor

Mr. Whorton briefed the Board on Bills filed in the current Legislative Session that the Board would be monitoring.

EXECUTIVE DIRECTOR’S REPORT

The Board was briefed on the recent Governor’s Executive Orders, and issues that will be discussed at the NCEES annual meeting in August. The Board reviewed the resume of Mr. Jim Minor and approved him to serve as a Board Technical Advisor.

CORRESPONDENCE

The Board reviewed correspondence from Joerg Wilmlink requesting that “Pro Success Engineering” be allowed to keep the word “Engineering” in its name without having to meet the Certificate of Authorization requirements. After this review the Board made the following motion:

23-088. IT WAS MOVED by Ms. Baldwin and seconded by Mr. Robinson that in order for “Pro Success Engineering” to use the term “Engineering” in its name it must meet the Certificate of Authorization requirements. MOTION CARRIED 9-0.

The Board reviewed correspondence from John Brown requesting that “Pre Engineered Steel Inc” be allowed to keep the word “Engineered” in its name without having to meet the Certificate of Authorization requirements. After this review the Board made the following motion:

23-089. IT WAS MOVED by Ms. Baldwin and seconded by Mr. Robinson that in order for “Pre Engineered Steel Inc” to use the term “Engineering” in its name it must meet the Certificate of Authorization requirements. MOTION CARRIED 9-0.

At 11:45 the Board hosted lunch with Members of the Board of Architects and their staff. Issues concerning both Boards were discussed. The Board returned to its regular session at 1:15 PM.

EXECUTIVE SESSION

At 1:55 pm, the Board determined that it wished to enter Executive Session to discuss the licensure application of Mark Jeffrey Boyles. Attorney Ben Albritton confirmed that it was permissible for the Board to enter Executive Session for this matter.

23-090. IT WAS MOVED by Mr. Whorton and seconded by Mr. Averrett that the Board go into executive session for fifteen minutes to discuss the application of Mark Jeffrey Boyles. MOTION CARRIED 9-0 with Ms. Baldwin, Mr. Averrett, Mr. Whorton, Mr.

Vaughn, Mr. Robinson, Mr. Breighner, Mr. Pegues, Ms. Walton and Mr. Johnson voting for the executive session.

At 2:03 pm the Board exited Executive Session and made the following motions:

23-091. IT WAS MOVED by Mr. Pegues and seconded by Mr. Averrett to deny the professional engineer licensure application of Mark Jeffrey Boyles. MOTION CARRIED 8-1 with Ms. Baldwin, Mr. Averrett, Mr. Whorton, Mr. Vaughn, Mr. Robinson, Mr. Breighner, Mr. Pegues, and Ms. Walton voting for the motion and Mr. Johnson voting no.
