# ALABAMA BOARD OF LICENSURE FOR PROFESSIONAL ENGINEERS AND LAND SURVEYORS MINUTES – OCTOBER 8, 2024

Montgomery, Alabama

The Alabama Board of Licensure for Professional Engineers and Land Surveyors was established by legislative action in 1935. Its charter is to protect the public by helping to safeguard life, health, and property, and to promote the public welfare by providing for the licensing and regulation of persons in the practices of engineering and land surveying. This purpose is achieved through the establishment of minimum qualifications for entry into the professions of engineering and land surveying, through the adoption of rules defining and delineating unlawful or unethical conduct, and through swift and effective discipline for those individuals or entities who violate the applicable laws or rules.

Board meeting notices are posted on the Open Meetings area of the website of the Secretary of State, and the Board's website under Dates and Deadlines. The public can also attend the meeting virtually via the "Board Meeting" link on the website.

#### LAND SURVEYING - EDUCATION & EXAMINATION - Mr. Joseph F. Breighner, Jr.

The Board reviewed correspondence from Denise Matthes of Troy University requesting the Board's opinion in reference to which courses the university offered that would meet the 15-hour course requirement for licensure. She also inquired if the 15-hour requirement was a "Hard and Fast" requirement or if 14 hours to include the 2-hour CAD class would be acceptable. After its review the Board determined to advise Ms. Matthes that the courses identified would meet the licensure requirements, however the 15 hours is a "Hard and Fast" requirement.

#### **EXECUTIVE DIRECTOR'S REPORT**

The Board reviewed the licensing stats showing the number of individuals licensed as Professional Engineers (235), Professional Land Surveyors (4), Engineer Interns (57), Surveyor Interns (3), and companies issued engineering (74) and land surveying (6) certificates of authorization for the fourth quarter of 2023-2024.

The Board determined that the firm's name "Eastern Engineered Wood Products, Inc" tended to convey the impression the firm was offering engineering services and made the following motion.

Dr. Tom Wade submitted a request that the Board modify a section of the Building Handbook regarding fire protection engineering. He specifically asked the Board to reply to the question: "Am I or am I not authorized to practice fire protection engineering, when I have been qualified through BELS by examination, experience, and education, and that I meet the definition of engineer per 34-11-1 (5), I regularly engage in the practice or engineering per 34-11-1 (12), and I offer services to practice engineering per 34-11-1 (13)?"

After its review and discussion, and on the advice of Board Counsel, the Board determined it would not provide a response to Dr. Wade.

#### **NEW BUSINESS**

The Board discussed its current Remote Supervision Policy along with other licensure requirements.

#### **ADJOURN TIME**
